Food will be available from a vendor and will be served by volunteer servers.

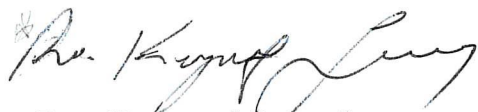
This letter is to serve as our acknowledgment that we will be serving alcohol at this event.

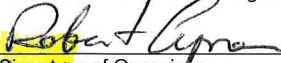

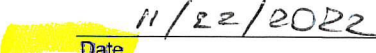

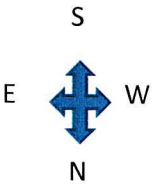
