BACKGROUND:

C&S Wholesale Groceries, a national grocery business through its wholly owned subsidiary, 1918 Winter Street Illinois LLC intends to purchase and operate the Mariano's grocery store at 545 N. Hicks Road. C&S has applied for a Class B-1 (packaged liquor), Class G (beer and wine) and a Class PS (product sampling) for the premise, which are the same liquor classifications currently held by Mariano's (Roundy's Illinois LLC).

C&S will maintain the same operations, services, floor layouts, managers/employees as the current licensee and utilize the existing Mariano's branding. From a customer-facing perspective, there will be no discernable impact to the existing grocery store.

Permitted hours of operation for a Class G liquor license are Sunday - Thursday 6 AM to Midnight and Friday & Saturday from 6 AM to 1 AM. Permitted hours of operation for a Class B-1 liquor license are 6 AM -12 AM.

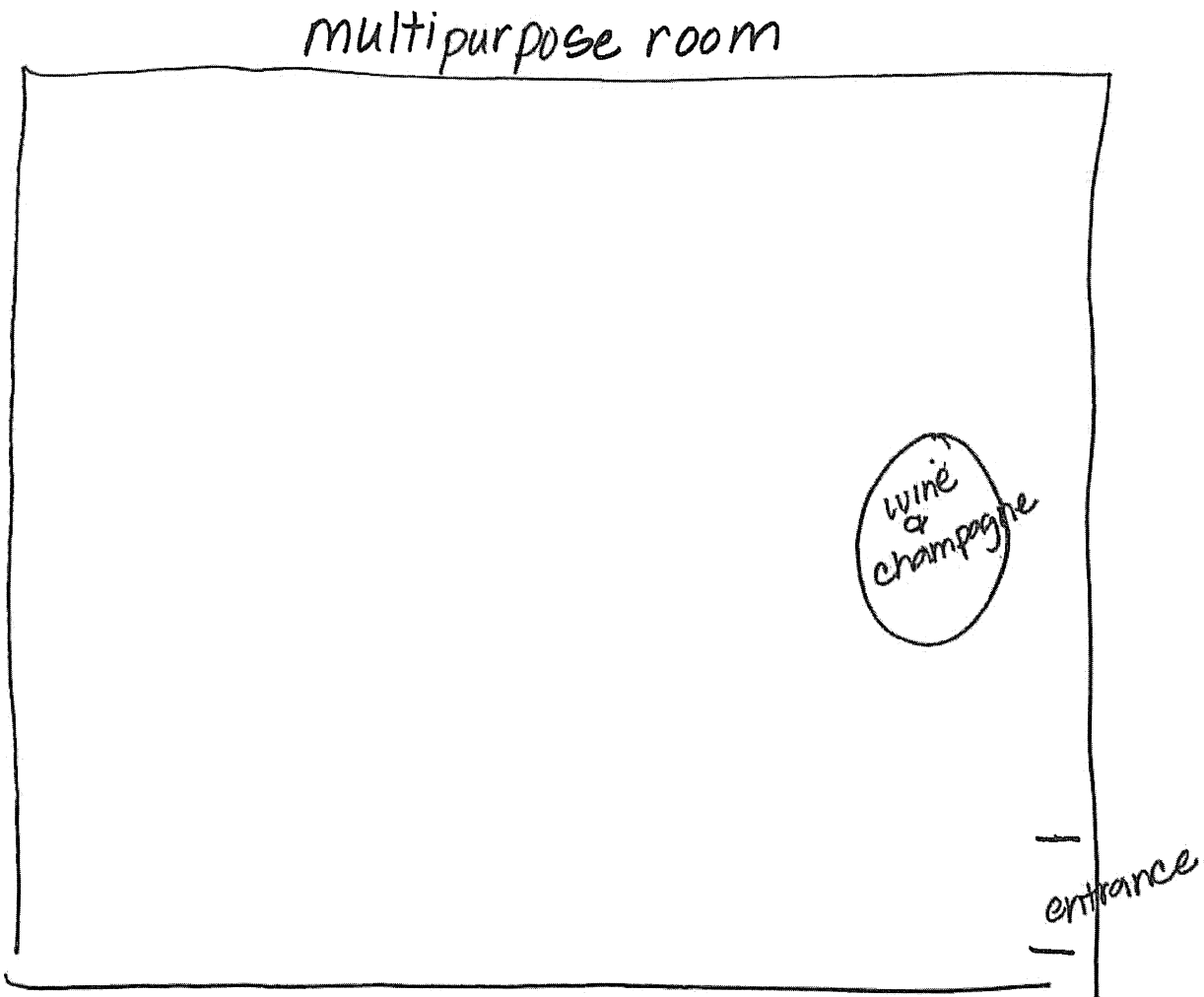
