BACKGROUND:

The Consolidated Election for Mayor, Clerk and Council Members in Districts #1, #4 and #6 was held on Tuesday, April 1, 2025. On April 22, 2025, the Cook County Clerk's Office completed a canvass of all votes cast, certifying the vote totals for Mayor, Clerk, and Council Members in Districts #1, #4 and #6.

KEY ISSUES:

The following results have been proclaimed to the Illinois State Board of Elections by the Cook County Clerk's Office.

MAYOR

(1) Jim Schwantz 6,316 votes (100%)

Jim Schwantz is elected to be the Mayor for the Village of Palatine.

CLERK

(1) No Candidate

The position of the Village Clerk for the Village of Palatine will be vacant until the appointment by the Mayor.

COUNCIL MEMBER - DISTRICT #1

(1) Greg Langer 633 votes (52.45%)

Greg Langer is elected to be the District #1 Council Member for the Village of Palatine.

COUNCIL MEMBER - DISTRICT #4

(1) Joe Falkenberg 620 votes (100%)

Joe Falkenberg is elected to be the District #4 Council Member for the Village of Palatine.

COUNCIL MEMBER - DISTRICT #6

(1) Brad Helms 1,490 votes (100%)

Brad Helms is elected to be the District #6 Council Member for the Village of Palatine.

Consider a Motion Concurring with the Mayor's Appointment for the Village Clerk

BACKGROUND:

Village Clerk Marg Duer did not run for reelection during the April 1, 2025 Consolidated Election and with no other candidate a vacancy in the office exists.

Pursuant to state statutes, the Mayor is required to present an individual to the Village Council for their consideration to fill the position. Mayor Schwantz is recommending Maureen Pasqualucci to fill the vacancy. Ms. Pasqualucci is a resident of Palatine and active with community groups.

The term is two years, subject to election in the 2027 Consolidated Election.
