Consider a Motion to Accept the Cook County Clerk's Official Results for the April 6, 2021 Consolidated Election

BACKGROUND:

The Consolidated Election for Mayor, Clerk and Council Members in Districts #1, #4 and #6 was held on Tuesday, April 6, 2021. On April 27, 2021, the Cook County Clerk's Office completed a canvass of all votes cast, certifying the vote totals for Mayor, Clerk, and Council Members in Districts #1, #4 and #6.

KEY ISSUES:

The following results have been proclaimed to the Illinois State Board of Elections by the Cook County Clerk's Office.

MAYOR

(1) Jim Schwantz 6,565 votes (100%)

Jim Schwantz is elected to be the Mayor for the Village of Palatine.

CLERK

(1) Margaret Duer 6,353 votes (100%)

Margaret Duer is elected to be the Village Clerk for the Village of Palatine.

COUNCIL MEMBER - DISTRICT #1

(1) Tim Millar 1,113 votes (100%)

Tim Millar is elected to be the District #1 Council Member for the Village of Palatine.

COUNCIL MEMBER - DISTRICT #4

(1) Greg Solberg 719 votes (100%)

Greg Solberg is elected to be the District #4 Council Member for the Village of Palatine.

COUNCIL MEMBER - DISTRICT #6

(1) Brad Helms 1,381 votes (100%)

Brad Helms is elected to be the District #6 Council Member for the Village of Palatine.
