BACKGROUND:

The Consolidated Election for Council Members in Districts #2, #3 and #5 was held on Tuesday, April 4, 2023. On April 25, 2023, the Cook County Clerk's Office completed a canvass of all votes cast, certifying the vote totals for District #2, #3 and #5.

KEY ISSUES:

The following results have been proclaimed to the Illinois State Board of Elections by the Cook County Clerk's Office.

COUNCIL MEMBER - DISTRICT #2

(1) Scott Lamerand 1,202 votes (100%)

Scott Lamerand is elected to be the District #2 Council Member for the Village of Palatine.

COUNCIL MEMBER - DISTRICT #3

(1) Doug Myslinski 607 votes (100%)

Doug Myslinski is elected to be the District #3 Council Member for the Village of Palatine.

COUNCIL MEMBER - DISTRICT #5

(1) Kollin Kozlowski 661 votes (100%)

Kollin Kozlowski is elected to be the District #5 Council Member for the Village of Palatine.
