Consider an Application for a Class D (Restaurant) Liquor License for SW2, LLC (d/b/a Chicago Culinary Kitchen) at 2391 N. Hicks Road

BACKGROUND: On this evening's agenda is a request for an increase in the number of Class D (Restaurant) liquor licenses for Chicago Culinary Kitchen, relocating an existing restaurant and catering business to 2391 N. Hicks Road. Permitted hours of operation for a Class D liquor license are Sunday - Thursday 6 AM to Midnight and Friday & Saturday 6 AM to 1 AM. Chicago Culinary Kitchen located at 773 N. Quentin Road currently holds a Class G (Beer and Wine) and Class P (Caterer) Liquor License.
