Overview

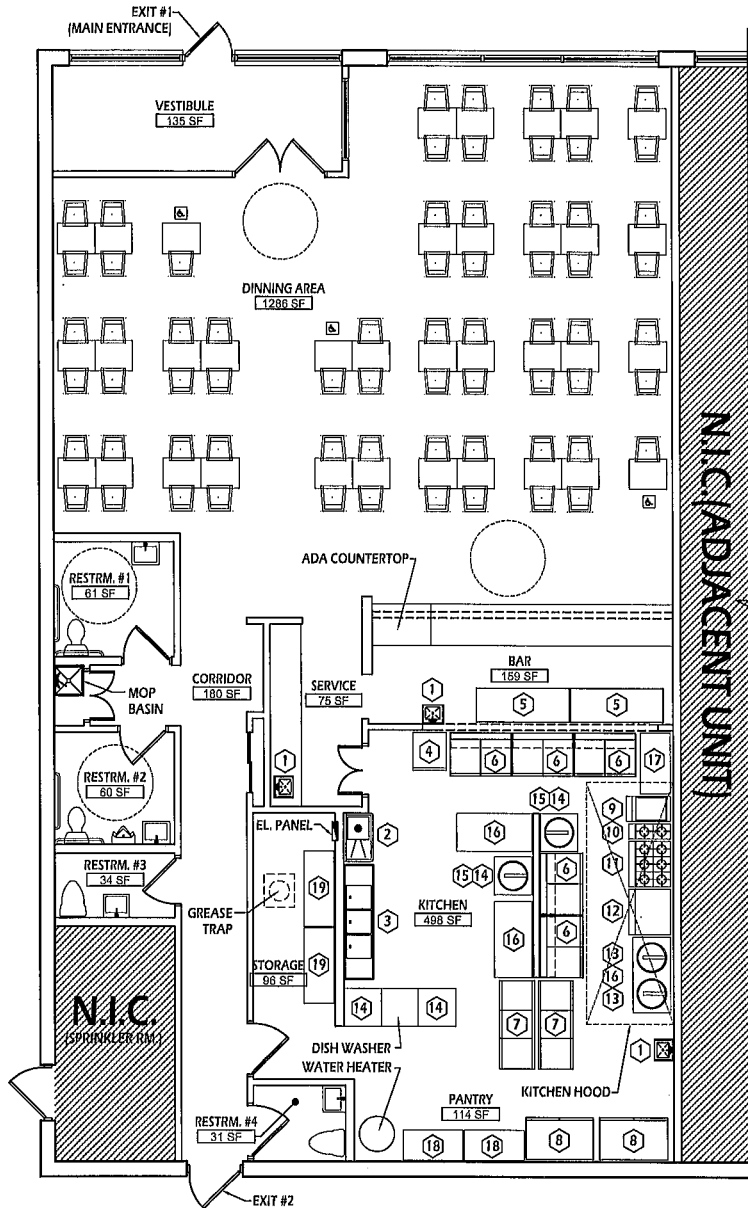

Vision and Marketing

The company will have financial stability for six months after opening, and will open a second store within two years, and the advantages of the current restaurant are the location and concept, and will make the most of these advantages, and marketing will be done systematically in accordance with the company's policy. 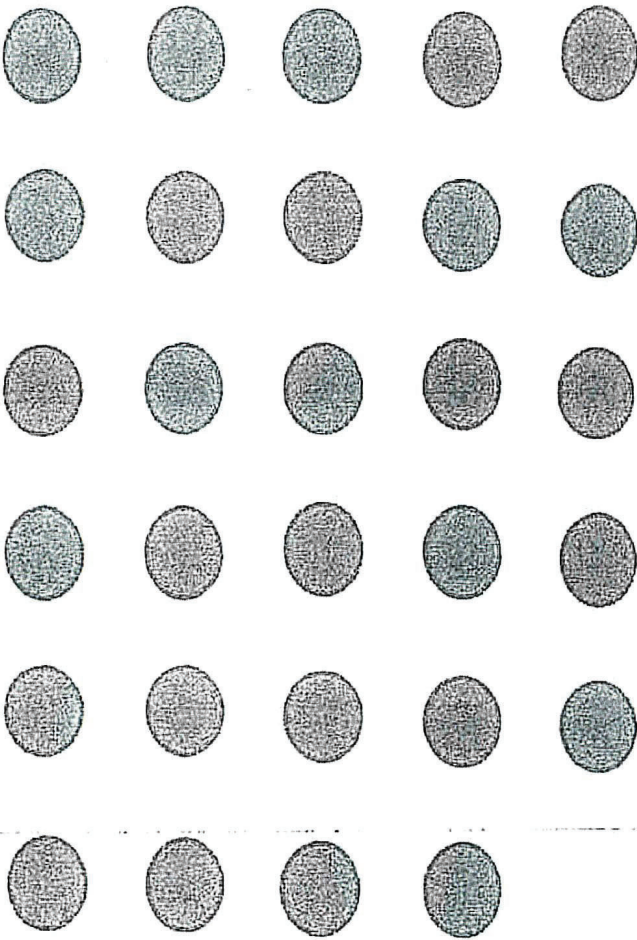
